The holder of this letter, AG SERVICIOS AERONAUTICOS C.A., whose headquarters are located at Costa del Sol Shopping Center, Floor # 4, local 110, Caribbean sector, La Guaira State, Postal code # 1165. Venezuela; is an approved RVSM monitoring partner to CSSI, Inc. CSSI, Inc. whose headquarters are located at 425 3rd Street, SW, Suite 700, Washington, DC 20024; is approved by the North American Approvals Registry and Monitoring Organization (NAARMO) which is administered by the United States Federal Aviation Administration (FAA); as well as the Regional Monitoring Agencies (RMAs) which were established by the International Civil Aviation Organization (ICAO) which includes the AAMA, ARMA, CARSAMMA, EUR RMA, EURASIA RMA, JASMA, MAAR, MIDRMA, NAARMO and PARMO to provide RVSM monitoring services for commercial and general aviation aircraft operators worldwide to both achieve and maintain RVSM approval status. CSSI, Inc., and our RVSM monitoring partner AR Servicios Aeronauticos CA have the authority to provide these RVSM monitoring services utilizing the CSSI, Inc. Enhanced 2GPS Monitoring Unit (E2GMU).

The E2GMU; jointly developed and designed by the United States Federal Aviation Administration (FAA) William H. Hughes Technical Center (WJHTC) located in Atlantic City, New Jersey and CSSI, Inc. (under contract to the WJHTC). The E2GMU utilizes Global Positioning System (GPS) technology to determine an aircraft's height-keeping performance. (This specially designed equipment utilizes GPS technology there is no requirement for this equipment to be "calibrated" and does not interfere with aircraft equipment or operators). CSSI, Inc. was granted exclusive authority by the WHJTC (NAARMO) to manufacture the E2GMU to support this worldwide safety effort. AG Servicios Aeronauticos CA is approved by both CSSI and the CARSAMMA to purchase a CSSI E2GMU to provide RVSM monitoring services (worldwide) for aircraft operators seeking to obtain initial approval or to maintain RVSM approval for their aircraft. As required by ICAO Annex 6, Operation of Aircraft, Parts I and II (November 20212), aircraft approved for RVSM operations must be monitored every two (2) years of 1,000 flight hours whichever is greater. As an approved RVSM monitoring partner to CSSI, Inc., AG Servicios Aeronauticos CA has the approval of both CSSI and the referenced RAMs to provide RAM monitoring services as requ4edd by the operators for this effort.

We thank you for your consideration in assisting AG Servicios Aeronauticos CA with accomplishing their duties in support of this important safe effort.
